

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to JACOB LAMPE FOUNDATION.ORG, and Jacob Richard Lampe Memorial Foundation, INC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Jacob Richard Lampe Memorial Foundation, INC include JACOB LAMPE FOUNDATION.ORG and JRL Memorial Foundation, INC. The JRL Memorial Foundation, INC website is a Charitable Foundation site. By using the JRL Memorial Foundation, INC website, you consent to the data practices described in this statement.

## Collection of your Personal Information

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our

  - Comply with an existing legal obligation; or
